**ORDER DIRECTING STAFF TO FILE A RECOMMENDATION  
REGARDING APPLICATION**

Kansas City Power & Light Company (KCP&L) filed an application on February 27, 2018, asking the Commission to approve exemplar tariff provisions that would modify KCP&L's existing tariffs regarding estimated billing and budget billing. KCP&L has not yet filed actual tariffs, but indicates it would like to file the exemplar tariffs in time to allow a new billing system to be implemented in May 2018.

Before considering KCP&L's application, the Commission will direct its Staff to file a recommendation regarding that application.

**THE COMMISSION ORDERS THAT:**

1. Staff shall file its recommendation regarding KCP&L's application no later than March 23, 2018.
2. Any party wishing to respond to Staff's recommendation shall do so no later than April 2, 2018.

3. This order shall be effective when issued.
