# ORDER DIRECTING THE PARTIES TO FILE A PROPOSED PROCEDURAL SCHEDULE

Anchor's Point Condominium Owners Association, Inc., (APCOA) filed a complaint with the Commission against TRR Management, LLC; Frank J. Steed, JR. d/b/a Steed Communities; JM Land Holdings, LLC; TRR Time Share, LLC; Carroll James Christiansen; Kimberling Inn, Inc.; and Kimberling Properties, Inc., (collectively "Respondents"). APCOA allege that Respondents are operating a water corporation and public utility under the jurisdiction of the Commission without a Certificate of Convenience and Necessity, that Respondents transferred the water system without Commission authorization, that Respondents are charging a rate not authorized by the Commission, and that Respondents are refusing to provide an accounting of costs related to system operation and maintenance.

Respondents filed an answer to the complaint, and the Commission's Staff (Staff) filed a report regarding the complaint. Staff's report determined that the Commission does

not have jurisdiction over Respondents. The Commission ordered APCOA to file a response to Staff's report. APCOA's response disagrees with Staff's analysis.

The Commission will direct the parties to work together to file a proposed procedural schedule and to select a date for an evidentiary hearing. The Commission will adjust the schedule if necessary.

## THE COMMISSION ORDERS THAT:

1. The parties shall work together to propose a procedural schedule.

2. Staff shall file the proposed procedural schedule, or a status report, no later

than February 26, 2020.

3. This order is effective when issued.
