On September 28, 2018, KCP&L Greater Missouri Operations Company ("GMO") submitted a letter and tariff designed to adjust its renewable energy standard rate adjustment mechanism pursuant to Commission Rule 4 CSR 240-20.100. The submitted tariff bears an effective date of December 1, 2018. The Commission will issue notice of the request and set an intervention deadline.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve a copy of this order upon the parties to KCP&L Greater Missouri Operations Company's previous renewable energy standard rate adjustment mechanism proceeding, File No. ET-2018-0090.
2. The Commission's Public Information Office shall make notice of this order available to the media in the service area of KCP&L Greater Missouri Operations Company and to the members of the General Assembly representing that service area.
3. Any person or entity wishing to intervene shall file an application to intervene no later than October 13, 2018.

4. This order shall be effective when issued.
