**ORDER GRANTING JOINT MOTION TO SUSPEND  
PROCEDURAL SCHEDULE**

On February 18, 2020, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri), on behalf of all the parties, filed a motion requesting that the procedural schedule for this case be suspended. Ameren Missouri relates that the parties have been engaged in settlement discussions and have agreed in principle to a settlement of the issues. In anticipation of filing a formal settlement agreement, the parties request that the remainder of the procedural schedule be suspended.

The Commission has considered the request and determines that it should be granted. The Commission will alter the procedural schedule as set out below.

**THE COMMISSION ORDERS THAT:**

1. The Joint Motion to Suspend Procedural Schedule filed on February 18, 2020, by Union Electric Company d/b/a Ameren Missouri is granted.
2. The requirements to file testimony on February 18, 2020, and for a March 19, 2020 procedural conference are suspended.
3. Union Electric Company d/b/a Ameren Missouri shall file a status report, no later than March 19, 2020, informing the Commission as to when it expects to file agreements regarding the issues the parties have settled.

4. This order is effective when issued.
