**ORDER GRANTING MEDIATION REQUEST,
SUSPENDING SCHEDULE, AND APPOINTING MEDIATOR**

Issue Date: February 18, 2020 Effective Date: February 18, 2020

On February 3, 2020, Spire Missouri, Inc., d/b/a Spire filed a request for mediation of Claude Scott’s complaint in this matter. The Commission allowed Mr. Scott until no later than February 18, 2020, to respond to Spire’s request. Mr. Scott’s timely response, submitted by email to Commission staff, indicates he agrees to mediation.

When mediation is ordered, Commission rule provides “[a]ll other actions on the case shall cease and all time limitations shall be tolled pending the completion of the mediation process.” 20 CSR 4240-2.125(2)(C).

The Commission will now suspend the procedural schedule and appoint a mediator.

THE COMMISSION ORDERS THAT:

1. Spire Missouri, Inc., d/b/a Spire’s request for mediation is granted.
2. The procedural schedule shall be suspended pending mediation.
3. Paul Graham, Regulatory Law Judge, is appointed mediator in this matter.

4. This order is effective when issued.
