On January 21, 2025,¹ the Commission ordered the the Staff of the Commission (Staff) and Spire Missouri Inc. d/b/a Spire to file a joint status report by March 10. On March 7, Staff filed a status report requesting additional time to discuss and finalize a resolution of the remaining issues. Staff requested an extension to March 28.

The Commission finds this request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's request for an extension is granted.
2. Staff shall file a joint status report or stipulation and agreement by March 28, 2025.
3. This order shall be effective when issued.
