NOTICE AND ORDER REGARDING COMPLIANCE TARIFFS

Issue Date: February 19, 2020

Effective Date: February 29, 2020

On January 21, 2020,¹ the Commission issued an Order Granting Certificate of Convenience and Necessity (Order) to Missouri-American Water Company (MAWC) to construct, install, own, operate, control, manage, and maintain a sewer system in the Clinton Estates service area. The order required MAWC to submit new and revised tariff sheets, to become effective before closing on the assets, to include:

- a. A service area map (Sheet No. MP 19.1);
- b. A service area written description (Sheet No. CA 18.1);
- c. Sewer rates (Sheet No. RT 3.1);
- d. Pump unit rules (Sheet No. 13.4)²;

² Staff's Memorandum dated January 10, 2020, referred to this sheet as "Sheet 13.4." Based on Staff's recommendation of that date and that designation, the Commission issued its January 21 Order, referencing the sheet to be revised as "Sheet 13.4." Staff's Compliance Tariff Recommendation, filed on February 10, then stated that "Sheet 13.4" was an erroneous designation. F.N. 1 The February 10 recommendation stated that the correct title for the sheet was "sheet R 13.4." Hereinafter, the sheet will be so designated.

e. Appropriate index modifications (Sheet Nos. IN 1.3, IN 1.4, IN 1.5), as applicable to sewer services in its Clinton Estates service area, to be included in its EFIS sewer tariff P.S.C. MO NO. 26.

MAWC submitted Tariff Revision numbered YS-2020-0120 on January 29 and Tariff Revision numbered JS-2020-0124 on February 5. YS-2020-0120 has an effective date of February 28, and JS-2020-0124 has an effective date of March 6. The Commission ordered Staff to file a recommendation on the former no later than February 10, with all other responses due on the same date; and to file a recommendation on the latter no later than February 15, with all other responses due on that same date. On February 10, Staff filed its Compliance Tariff Recommendation on both YS-2020-0120 and JS-2020-0124. No other responses to the proposed tariffs were filed.

In its recommendation, Staff notes the Commission's January 21 Order required a revision of Sheet No. R 13.4. The recommendation states this Order was based on Staff's request and that its request overlooked that Sheet No. R 13.4 was inapplicable to the Clinton Estates system because the system is gravity fed. Staff's recommendation states MAWC and Staff have conferred and agree that Sheet No. R 13.4 needs no revision and explains that for this reason, MAWC has not filed a revised Sheet No. R 13.4. Staff moves the Commission to revise its Order by removing the requirement that MAWC file a revised tariff Sheet R 13.4. Staff further recommends approval of:

Original Sheet No. MP 19.1
Original Sheet No. CA 18.1
3rd Revised Sheet No. RT 3.1, Cancelling 2nd Revised Sheet No. RT 3.1

Based on Staff's recommendation and the parties' agreement, the Commission will vacate its requirement that MAWC submit a revised Sheet R 13.4. The Commission gives notice that the tariff sheets with tracking number YS-2020-0120 will go into effect on February 28, 2020. Finally, the Commission will approve and order that tariff sheets with tracking number JS-2020-0124 shall go into on March 6, 2020.

Because the Commission directed MAWC to submit tariff sheets that can go into effect before the closing on the assets, the Commission finds good cause exists to allow this order to go into effect in less than thirty days.

THE COMMISSION ORDERS THAT:

1. The requirement of the Commission's Order Granting Certificate of Convenience and Necessity³ that Missouri-American Water Company revise Sheet No. R 13.4 is vacated.
2. The tariff sheets in Tariff No. JS-2020-0124 issued on February 5, 2020, shall take effect on March 6, 2020.
3. This order shall be effective on February 29, 2020.
