ORDER DIRECTING A STAFF TARIFF RECOMMENDATION AND SETTING TIME FOR RESPONSES

On March 6, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed tariff sheets, Tracking No. JE-2025-0132, to correct tariff sheets with duplicate sheet numbers. Those tariff sheets bear an effective date of April 5, 2025. The Commission will direct its Staff to analyze the tariff sheets and file a recommendation. The Commission will also set a deadline for any other responses to Evergy Missouri Metro's tariff sheets.

THE COMMISSION ORDERS THAT:

1. Staff must file a recommendation about Evergy Missouri Metro's tariff sheets no later than March 17, 2025.
2. Any other responses to Evergy Missouri Metro's tariff sheets must be filed no later than March 17, 2025.
3. This order is effective when issued.
