## **ORDER DIRECTING FILING OF STATUS REPORT**

On December 17, 2018, the Staff of the Commission filed a recommendation and memorandum regarding its review of Spire Missouri, Inc. d/b/a Spire Missouri's 2016-2017 Actual Cost Adjustment for Spire Missouri's East service area (referred to as "Spire Missouri East").<sup>1</sup> In that filing, Staff recommended an adjustment to reduce Spire Missouri East's gas costs. Spire Missouri responded by stating that it and Staff agreed to meet in order to resolve the discrepancies that Staff noted. The parties met on April 10, 2019, and Staff has filed status reports every few months indicating that the parties continue to gather additional information in order to work out their disagreements. Staff stated in its most recent status report filed on February 20, 2020, that it intends to file an additional status report no later than March 20, 2020.

The Commission will order Staff to file an additional status report or recommendation stating if additional time is needed for settlement discussions, if a procedural conference is necessary to establish a procedural schedule, or providing the Staff's recommendation in this matter.
