On August 29, 2019, Confluence Rivers Utility Operating Company, Inc. filed notices opening two staff assisted rate cases under Commission Rule 20 CSR 4240-10.075. On February 10, 2020, the parties filed a *Unanimous Agreement Regarding Disposition of Small Utility Company Revenue Increase Request (Agreement)*.
