ORDER SETTING TIME TO RESPOND TO STAFF'S RECOMMENDATION

Issue Date: February 24, 2020

On January 31, 2020, Union Electric Company d/b/a Ameren Missouri submitted an application requesting authority to issue and sell up to \$465,000,000 aggregate principal amount of additional long-term indebtedness. Ameren Missouri seeks expedited treatment of its financing application and requests that a Commission order on the application go into effect no later than March 23, 2020. On February 21, 2020, the Staff of the Missouri Public Service Commission submitted a recommendation that the Commission approve the financing request with proposed conditions.

The Commission will direct Ameren Missouri to file a response to Staff's recommendation and indicate whether it accepts Staff's proposed conditions. Ameren Missouri's response to Staff's recommendation must be submitted no later than February 28, 2020, to enable expedited treatment of Ameren Missouri's application. The Commission will also establish a deadline for any other responses to Staff's recommendation.

THE COMMISSION ORDERS THAT:

1. Union Electric Company d/b/a Ameren Missouri shall file a response to Staff's recommendation no later than February 28, 2020.
2. Should the Office of the Public Counsel wish to file a response to Staff's recommendation, such response shall be filed no later than February 28, 2020.
3. This order shall be effective when issued.
