# ORDER RE-SETTING PREHEARING CONFERENCE

On September 18, 2019, Unice Harris filed a complaint against Kansas City Power & Light Company.<sup>1</sup> The Commission had previously scheduled a prehearing conference for February 11, 2020. Ms. Harris requested that the February 11 prehearing conference be postponed to allow an attorney to enter an appearance. The Commission granted her request, and allowed 15 days for the attorney to enter an appearance before the prehearing conference would be rescheduled. No appearance has been entered.

The Commission will now reschedule the prehearing conference. For their convenience, the parties may appear by telephone as set out below.

# THE COMMISSION ORDERS THAT:

1. The parties shall appear at a prehearing conference to be held on March 11, 2020, at noon. Failure to appear at the conference without being excused may

result in dismissal of the complaint in accordance with Commission rule 20 CSR 4240-2.090(5).

2. The prehearing conference will convene in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri 65102. The building meets accessibility standards required by the Americans with Disabilities Act.
