On February 14, 2020, the City of Union, Missouri and Public Water Supply District No. 1 of Franklin County, Missouri filed the above-referenced pleading. Section 247.172, RSMo, requires that the Commission act on the application no later than 120 days after the application was filed.

The Commission will give notice of this application to the general public and interested persons and set a date for intervention. The Commission's Data Center shall mail a copy of this notice to the Franklin County Commission. In addition, the Commission's Public Policy and Outreach Department shall make notice of this order available to the media serving Franklin County, and to the members of the General Assembly representing Franklin County.

The Commission will also order its Staff to file a recommendation regarding the application.

### THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall serve notice as set out in the body of this order.

2. The Commission's Public Policy and Outreach Department shall serve notice as set out in the body of this order.

3. Any entity wishing to intervene in this matter shall file an application to do so no later than March 10, 2020.

4. No later than March 20, 2020, the Staff of the Missouri Public Service Commission shall file its recommendation in this matter.

5. This order shall be effective when issued.
