ORDER SETTING EVIDENTIARY HEARING

Issue Date: February 26, 2020

On January 31, 2020,¹ this matter was set by agreement for an evidentiary hearing on February 13 in St. Joseph, Missouri. The hearing was then continued because of weather, and the Commission issued an order requiring the parties to confer and file proposed dates for an evidentiary hearing in St. Joseph after March 15. On February 21, the parties proposed the case be set for an evidentiary hearing in St. Joseph on April 1. They also advised that Ms. Stinnett is moving to Eminence, Missouri, in March, would like for the hearing to be held near her new residence, but would travel to St. Joseph if necessary. The Company stated it would not agree to a hearing in the Eminence location and that the case should be heard in St. Joseph.

The Commission notes that Eminence and the offices of the Company's attorneys are, respectively, about 132 and 158 miles from Jefferson City; and that Eminence and Jefferson City are, respectively, about 356 and 212 miles from St. Joseph. The Commission will re-set the evidentiary hearing in Jefferson City on April 1.

An evidentiary hearing in this case shall occur on April 1, 2020, commencing at 11:00 a.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 310. This building meets accessibility standards required by the Americans with Disabilities Act.
