On February 3, 2020, Spire Missouri, Inc. (the “Company”), filed the above-referenced application. The Company amended its application on February 6, 2020. The application seeks, among other things, permission and approval and a certificate of convenience and necessity (“CCN”) to construct, install, own, operate, maintain, and otherwise control and manage a natural gas distribution system to provide gas service in Lawrence County, Missouri, as a further expansion of the Company’s existing certificated area.

The Commission issued notice of the application on February 10, 2020, and allowed potential intervenors until February 25, 2020 to request intervention. The Commission received no intervention requests.

The Commission will order its Staff to file a Recommendation.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation no later than March 23, 2020.
2. This order shall become effective immediately upon issuance.
