NOTICE CLOSING FILE

Issue Date: February 26, 2020

Cloris and Ronald Torrey filed a complaint against Laclede Gas Company on October 31, 2014. The Commission issued an order on August 19, 2015, effective September 18, 2015, that granted Laclede' motion to dismiss that complaint as moot. The complaint was dismissed without prejudice, meaning it could be refiled if the complainants chose to do so.

Among other things, the Commission's *Order Granting Motion to Dismiss* stated that Cloris and Ronald Torrey had appeared at a prehearing conference on June 1, 2015, and presented a document entitled *Affidavit 'Rejection of Invitation to Contract for Discovery'*. The *Order* indicates Cloris and Ronald Torrey then left the hearing room without making any oral statement.

On February 21, 2020, Cloris Torrey filed a pleading entitled *Declaration of Protest*. That pleading includes a notarized statement from Cloris Torrey in which she states that she was not at the location of the June 1, 2015 prehearing conference and was not in the conference room. She also denies having appeared or presented the

Affidavit "Rejection of Invitation to Contract for Discovery". The pleading demands the Commission "correct and fix record under the seal, or prove stated claim as false."

The Commission notes that Cloris Torrey's appearance or non-appearance at the prehearing conference was not the basis for the Commission's 2015 order dismissing the complaint. Further, Ms. Torrey's *Declaration of Protest* and the factual correction she offers in that declaration are now a part of the record of this case.

No further action by the Commission is required and this file shall be closed.
