### ORDER APPROVING COMPLIANCE TARIFF

On February 21, 2025, Confluence Rivers Utility Operating Company, Inc., (Confluence Rivers) filed tariff sheets, Tracking No. JS-2025-0125, to comply with the Commission's January 2, 2025, *Order Approving Acquisition of Assets and Granting a Certificate of Convenience and Necessity*. On March 3, 2025, Confluence Rivers substituted its tariff submission and withdrew unnecessary tariff sheets after discussions with the Commission's Staff. The proposed tariff sheets bear an effective date of March 23, 2025.

On March 5, 2025, Staff recommended that the Commission approve the tariff sheets. No other responses to the tariff sheet were received.
