**ORDER GRANTING MOTION TO AMEND PROCEDURAL SCHEDULE**

Effective Date: August 12, 2021

On May 26, 2021,<sup>2</sup> the Commission issued its Order Setting Procedural Schedule and Suspending Tariffs (“May 26 Procedural Schedule”). This order set deadlines for filing pre-filed testimony, with rebuttal testimony due no later than August 13 and surrebuttal testimony due no later than September 10. On August 12, the Office of Public Counsel (“OPC”) filed a Motion to Amend the Procedural Schedule requesting that the due dates for rebuttal and surrebuttal testimony be set back respectively to August 16 and September 13. The Commission will grant the Motion.

**THE COMMISSION ORDERS THAT:**

1. OPC’s Motion to Amend the Procedural Schedule is granted.
2. The May 26 Procedural Schedule is amended such that all rebuttal testimony filed by any party shall be filed no later than August 16, 2021, and all surrebuttal testimony filed by any party shall be filed no later than September 13, 2021.
3. Except as hereinstated, the May 26 Procedural Schedule shall remain in full force and effect.
