**ORDER APPROVING COMPLIANCE TARIFF**

On February 22, 2025, Confluence Rivers Utility Operating Company, Inc., (Confluence Rivers) filed an adoption notice for Gascony Water Gascony’s Certificate of Convenience and Necessity along with a tariff sheet, Tracking Nos. JW-2025-0126, to comply with the Commission’s December 19, 2024, *Order Approving Acquisition, Canceling Certificate and Granting a Certificate of Convenience and Necessity*. The tariff sheet bears an effective date of March 24, 2025.

On March 4, 2025, Staff recommended that the Commission approve the tariff sheet. No other responses to the tariff sheet were received.

Upon reviewing the pleadings and Confluence Rivers proposed tariff sheet, the Commission finds the tariff sheet complies with the Commission’s order and will approve it. To enable the tariff to become effective on the date requested by Confluence Rivers, the Commission finds it reasonable to make this order effective in less than 30 days.
