MOTION TO INTERVENE OF SPIRE MISSOURI INC.

COMES NOW Spire Missouri Inc. (“Spire Missouri” or “Company”) and, pursuant to Commission Rule 20 CSR 4240-2.075, files this Motion to Intervene, and in support thereof respectfully states as follows:

1. On February 24, 2021, Evergy Missouri West, Inc. d/b/a Evergy Missouri West and Evergy Metro, Inc. d/b/a Evergy Missouri Metro (collectively “Evergy”) filed an Application of Evergy Missouri Metro and Evergy Missouri West for an Order Related to the Approval of a Transportation Electrification Portfolio.
2. The Commission issued an order setting an intervention deadline of March 19, 2021.
3. Spire Missouri is a corporation duly incorporated under the laws of the State of Missouri. The Company’s principal office is located at 700 Market Street, St. Louis, Missouri 63101. Spire Missouri is a gas corporation and energy provider to 1.1 million customers, many of whom also receive electric service from Ameren Missouri, the applicant in this proceeding. The contact information for Spire Missouri’s attorneys is set forth below.
4. Evergy is seeking the Commission’s approval to implement tariffs that authorize and enable a Transportation Electrification (“TE”) pilot program. Discussion regarding these issues are of interest to Spire whose business is directly related to

matters like electrification. As an investor-owned gas utility regulated by this Commission, whose service territory overlaps with Evergy, Spire Missouri has a direct interest in the issues presented in Evergy's transportation electrification filing. Spire Missouri's intervention is in the public interest, as Spire Missouri's participation may aid the Commission in addressing the implications associated with the matters included in Evergy's filing.

5. Spire Missouri does not take a position on any specific issue at this time but may develop positions on specific issues as this case proceeds.
6. Communications, correspondence, orders and decision in this matter should be addressed to the undersigned.

WHEREFORE, Spire Missouri respectfully requests that the Commission issue its order granting intervention and permitting the Spire Missouri Inc. to intervene and participate as a party in all respects in this proceeding.
