ORDER ESTABLISHING TIME TO RESPOND TO STAFF RECOMMENDATION

On December 1, 2021, Evergy Missouri Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively Evergy) filed their *Application for Approval of the Income-Eligible Weatherization Tariff, Automation of the Income-Eligible Weatherization Program, and Motion for Variance of 60-Day Notice*. On December 1, 2021, the Commission issued its order requiring the Commission's Staff to file a recommendation advising either approval or rejection of Evergy's Application, and giving the reasons therefor no later than December 15, 2021. On December 15, 2021, Staff recommended that the Commission approve Evergy's application.

The tariffs filed in this case by Evergy will become effective on December 31, 2021 unless adversely ruled upon or suspended by the Commission. In order to accommodate the time constraints of the case, the Commission will shorten the time for responding to Staff's recommendation to December 20, 2021.

THE COMMISSION ORDERS THAT:

1. Any party wishing to respond to Staff's recommendation shall do so no later than December 20, 2021.

2. This order shall be effective when issued.
