**MOTION FOR EXPEDITED TREATMENT**

**COMES NOW** White River Valley Electric Cooperative, Inc. (“White River”) pursuant to 20 CSR 4240-2.080, and for its *Motion for Expedited Treatment* ("*Motion*"), respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. White River filed its Application for Approval of Designated Service Boundaries Within Portions of Christian County, Missouri on February 19, 2025 (“Application”).
2. White River’s Application was filed pursuant to RSMo 386.800.3 which “requires the Commission to rule on an application no later than 120 days from the application’s filing date, unless otherwise ordered by the Commission for good cause shown [...].”
3. As stated in White River’s Affidavit and Verification dated February 18, 2025, attached to its Motion for Waiver of 60 Day Notice, the landowner/developer have expressed that time is of the essence in obtaining an electric supplier for the subject property to allow the timely completion of the construction schedule. See *Affidavit and Verification* at ¶ 3.
4. White River has been notified by the landowner/developer that it expects to obtain approval to break ground soon and will need electric service by late spring. Therefore, White River requests that this Application be expedited in order to prevent harm to the landowner/developer and new members/customers of the development which would

occur should this case be extended beyond 90 days.

5. White River respectfully requests that the Commission rule on the Application no later than May 20, 2025, 90 days from the Application's filing date.
6. This Motion was filed as soon as White River became aware of the anticipated groundbreaking timeline and associated need for electric service by the landowner/developer.

WHEREFORE, White River requests an expedited Order of the Commission directing that the Commission rule on the Application no later than May 20, 2025. White River requests such other and further relief as is just and proper under the circumstances.
