ORDER SUSPENDING TARIFFS

Issue Date: March 21, 2023

Effective Date: March 21, 2023

On March 20, 2023, the Staff of the Commission (Staff) filed a Motion to Suspend Tariffs and Motion for Expedited Treatment (Motion). The above-reference tariff sheets were filed on February 21, 2023, and they bear effective dates of March 23, 2023.

Staff explains that these tariff sheets, which are for Limited Large Customer Economic Development Discount Riders, contain several terms that are either not defined or that are poorly defined. Thus, Staff asks for the Commission to suspend the tariff sheets for 180 days to allow time for discovery and to allow time for correcting Staff's concerns. Because the tariff sheets bear an effective date of March 23, 2023, Staff asks for expedited treatment. Staff requests the Commission to grant the motion no later than March 22, 2023.

The Commission finds Staff's Motion reasonable. Therefore, the Commission will suspend the tariff sheets.

THE COMMISSION ORDERS THAT:

1. The Motion for Expedited Treatment is granted.
