On March 13, 2025, the Staff of the Commission (Staff) filed a *Staff's Status Report*. The Commission had previously directed Staff to file a recommendation regarding this joint application no later than March 14, 2025.

The Request sought an extension of time for the filing of Staff's recommendation to April 18, 2025. The Request stated that responses to data requests are not yet due and Staff will need additional time to properly analyze the data requests as well as determine if further data requests are necessary to be submitted. The Commission finds the Request reasonable and will grant it.

1. The Request is granted. Staff's report shall be filed no later than April 18, 2025.
2. Any entity wishing to request a hearing in this matter shall file an application to do so on or before April 25, 2025.
3. This order shall be effective when issued.
