## ORDER SETTING TIME TO RESPOND

On March 13, 2025, The Empire District Electric Company d/b/a Liberty filed its *Motion for Expedited Treatment*. Liberty asks that the Commission grant expedited treatment of its SUTC true-up adjustment tariff, Tracking No. JE-2025-0129, which bears an effective date of May 1, 2025. Liberty requests that the Commission allow the SUTC true-up adjustment tariff to become effective on April 1, 2025.

Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission.

The Commission will shorten the time for any responses or objections to Liberty's *Motion for Expedited Treatment*.

### THE COMMISSION ORDERS THAT:

1. Any responses or objections to Liberty's *Motion for Expedited Treatment* must be filed no later than March 17, 2025.
