**STAFF RECOMMENDATION TO APPROVE
PROPOSED REVISED TARIFF SHEET**

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through the undersigned counsel, and files its *Staff Recommendation to Approve Proposed Revised Tariff Sheet* in response to the Commission’s March 5, 2025, *Order Granting Certificate of Convenience and Necessity (Order)*, and states as follows:

1. On December 10, 2024, Spire Missouri, Inc. d/b/a Spire (“Spire”), filed an *Application* with the Missouri Public Service Commission (“Commission”) requesting a Certificate of Convenience and Necessity (“CCN”) to install, own, construct, operate, control, manage, and maintain a natural gas distribution system to provide natural gas in Cedar County, Missouri, as an addition to Spire’s existing service territories.
2. On February 21, 2025, Staff filed its Staff Recommendation that the CCN should be granted subject to conditions set forth in its Staff Memorandum.
3. On February 25, 2025, Spire filed its Response to Staff’s Recommendation, wherein, it agreed to the recommendation as well as the conditions.
4. On March 5, 2025, the Commission granted Spire’s Application for a CCN subject to the conditions, and ordered a revised tariff sheet be filed by Spire to include

Section 26, Township 36 North, Range 28 West of Cedar County as part of its certificated area.

5. On March 6, 2025, Spire filed a revised tariff sheet that includes the subject area of the CCN request, which would satisfy Staff's recommended condition. The revised tariff sheet had an effective date of April 5, 2025, and was assigned Tracking No. JG-2025-0131.

6. On March 10, 2025, the Commission ordered Staff to file a recommendation regarding said tariff sheet no later than March 21, 2025.

7. Staff has reviewed the tariff sheet filed on March 6, 2025, with an issue date of March 6, 2025, and an effective date of April 5, 2025, and assigned Tracking No. JG-2025-0131, and recommends the Commission approve or allow to go into effect for service as follows:

Second Revised Sheet No. 21.3, Cancelling First Revised Sheet No. 21.3

WHEREFORE, Staff recommends the Commission approve Spire's updated tariff sheet as listed in paragraph 7 above, Tariff Tracking No. JG-2025-0131, with an effective date of April 5, 2025, or allow the same tariff sheet to go into effect by operation of law.
