ORDER EXTENDING TIME FOR STAFF RECOMMENDATION

On December 17, 2024, the Commission issued an order granting its Staff an extension to March 17, 2025 to file a recommendation with regard to Evergy Missouri West, Inc. d/b/a Evergy Missouri West's application, or a status report stating when it expected to file a recommendation.

On March 14, 2025, Staff filed a *Motion for Extension* in which it stated that, on February 27, 2025, Evergy Missouri West informed Staff of material facts that could affect Staff's recommendation on the Sunflower Sky solar farm portion of the application. Staff is currently pursuing discovery regarding this development and requests additional time to continue discovery and draft its recommendation.

The Commission finds Staff's request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than April 17, 2025, Staff shall file a recommendation regarding Evergy Missouri West's application or a status report stating when it expects to file a recommendation.
2. This order shall be effective when issued.
