The Commission opened this file on July 11, 2018, to assist its Staff in its consideration of a new affiliate transaction rule to apply to water corporations and sewer corporations with 8,000 or fewer customers. Staff filed a draft rule on September 16, 2019, and on February 18, 2020, filed a motion asking the Commission to allow interested stakeholders until March 20, 2020 to file comments regarding the costs that may be incurred to comply with the draft rule. The Commission will do so.

### THE COMMISSION ORDERS THAT:

1. Any stakeholder wishing to offer comments regarding the costs that may be incurred to comply with Staff's draft rule shall do so by March 20, 2020.
2. This order shall be effective when issued.
