ORDER EXTENDING DEADLINE FOR STAFF RECOMMENDATION

Issue Date: February 28, 2020

On December 27, 2019, Liberty Utilities (Missouri Water) LLC d/b/a Liberty Utilities and The Empire District Electric Company (applicants) filed a Joint Application (application) asking the Commission to approve a sale and transfer of water utility assets between the applicants. On December 27, the Commission issued its Order Directing Notice, Setting Intervention Date and Directing Staff to File a Recommendation. The order directed the Commission Staff to file its recommendation no later than March 2, 2020.¹ On February 28, the Commission Staff filed a Motion for Additional Time to March 27, 2020 to File Staff Recommendation. Staff's motion states Staff submitted a data request to Liberty Utilities on February 27 and that because of the twenty days permitted for response and the time Staff will need thereafter to develop its recommendation, Staff may need until March 27 to file its recommendation. Staff's motion states the applicants do not oppose the motion. The Commission will grant the motion.

1. The Commission Staff's Motion for Additional Time to March 27, 2020 to File Staff Recommendation is sustained.
2. The Commission's Staff shall file its recommendation on the application no later than March 27, 2020.
