## ORDER MODIFYING HEARING SCHEDULE AND SETTING TIME FOR RESPONSES

Issue Date: March 3, 2020

Effective Date: March 3, 2020

On February 28, 2020, Union Electric Company d/b/a Ameren Missouri, on behalf of all the parties, filed a Non-Unanimous<sup>1</sup> Stipulation and Agreement, and on March 2, 2020, filed a corrected agreement. The corrected agreement states that the parties have resolved all the contested issues except for the Fuel Adjustment Clause (FAC) sharing ratio and affiliate transactions issues raised by the Office of the Public Counsel.

The evidentiary hearing is scheduled to begin on Monday, March 9, 2020. According to the current proposed order of witnesses and list of issues, the two outstanding issues are scheduled to be heard on Wednesday, March 11, 2020, and Thursday, March 12, 2020. Therefore, the Commission will reschedule the start of the hearing to begin on March 11, 2020. The parties should be prepared to give opening statements and present these issues in the order previously proposed. However, the witnesses currently scheduled for Thursday should be available on Wednesday afternoon in case the proceeding moves rapidly and can be completed earlier than scheduled. The Commission will modify the procedural schedule as set out below.

<sup>1</sup> The agreement was signed by all the parties except Renew Missouri Advocates, which indicated that it had no objection to the terms of the agreement.

Additionally, 20 CSR 4240-2.115(2)(B) allows each party seven days to file an objection to a nonunanimous stipulation and agreement. If no objection is filed, the Commission may treat the non-unanimous stipulation and agreement as unanimous. Therefore, the Commission will set out the deadline for responses or objections to the Corrected Non-Unanimous Stipulation and Agreement.

**THE COMMISSION ORDERS THAT:**

1. The hearing schedule is amended so that the evidentiary hearing is set for **March 11-13, 2020**, beginning at **9:00 a.m.** on the first day. The hearing will be held at the Commission's office at the Governor Office Building, Room 310, 200 Madison Street, Jefferson City, Missouri. This building meets accessibility standards required by the Americans with Disabilities Act. 2. Any responses or objections to the Corrected Non-Unanimous Stipulation and Agreement filed on March 2, 2020, shall be filed no later than March 9, 2020.


