NOTICE THAT TARIFF WILL BE ALLOWED TO GO INTO EFFECT

On February 7, 2020, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) filed a proposed tariff sheet, Tracking No. YE-2020-0136. This tariff sheet was filed to expand the availability of its Missouri Energy Efficiency Investment Act (MEEIA) Residential Single Family Low-Income Program (SLFI) to include attached dwellings of four or fewer units. The tariff sheet bears a March 8, 2020 effective date.

The Commission directed Staff to file a recommendation and any other party to file its response to the tariff no later than February 20, 2020. Staff filed its recommendation on February 20, 2020. No other responses were received.

Staff reviewed the revised SFLI tariff sheet and recommended it be allowed to become effective on March 8, 2020. Staff indicated that the revision changes the SFLI program to include attached dwellings of four or fewer units as eligible to participate.

The Commission has considered the tariff sheet and Staff's recommendation. Since there is no opposition to the tariff sheet taking effect, the Commission will allow Tariff No. YE-2020-0136 to take effect by operation of law.
