STAFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through the undersigned counsel, and for its *Staff Recommendation* respectfully states as follows:

- 1. Evergy Metro Inc., d/b/a Evergy Missouri Metro ("EMM"), Evergy Missouri West, Inc. d/b/a Evergy Missouri West ("EMW") (collectively, "Evergy"), the Office of the Public Counsel, and Renew Missouri Advocates d/b/a Renew Missouri filed a Non-Unanimous Stipulation and Agreement ("Agreement") on September 27, 2024. Staff filed its response on October 4, 2024, indicating that Staff did not oppose the Agreement.
- 2. On March 6, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro ("EMM") filed a tariff revision for JE-2025-0132 for the purpose of making corrections to sheet numbers. The EMM Rehousing tariffs (sheet numbers 2.37 and 2.38) were originally filed on October 16, 2023, with an effective date of November 16, 2023. EMM subsequently filed revisions (JE-2025-0115) to sheet 2.37 on January 17, 2025, with an effective date of February 16, 2025. When EMM filed the MEEIA 4 tariffs in Docket No. EO-2023-0369, it inadvertently assigned the Modified PAYS tariffs sheet numbers 2.37-2.40, not realizing that sheets 2.37 and 2.38 had already been assigned to the Rehousing tariffs.

- 3. EMM subsequently filed substitute tariffs for the Modified PAYS tariffs on December 10, 2024, renumbering those sheets 2.39-2.42 (Tracking No. JE-2025-0051). The Commission issued an order approving the tariffs, including the substitutes filed on December 10, 2024. The Commission cancelled the original sheet 2.37 under the MEEIA docket, effective January 1, 2025. However, the stamped copies EMM received still had the original Modified PAYS sheet numbers 2.37-2.40. For current tariffs, EFIS shows the Rehousing tariff as sheet 2.37, 2nd revised effective February 16, 2025; however, sheet 2.38, 1st revised is the second page of the Modified PAYS tariff, effective January 1, 2025. Sheet 2.38 should be the second page of the Rehousing Program. Sheets 2.39-2.42 of the Modified PAYS program are correct with an effective date of January 1, 2025.
- 4. Staff recommends the corrections laid out above be made as identified and described by EMM in the cover letter to their March 6, 2025, tariff revision filing (JE-2025-0132) in this matter.

WHEREFORE Staff respectfully submits this *Staff Recommendation* for the Commission's information and consideration, and to grant such other and further relief as the Commission considers just and reasonable under the circumstances.
