## 20 CSR 4240-23.010 (6), (7) – Highest 5% SAIFI Circuits Assessment

Patrols and repairs are planned to complete in the 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup> Quarters of 2022. For circuits where analysis is required, a systematic patrol plan is developed based on identified outage causes. When and where feasible, repairs are made during the initial patrol. Tree patrols will be performed where indicated and spot trimming performed as needed. Other maintenance, modifications, or upgrades not completed during the initial patrol will be completed by the end of the 4<sup>th</sup> Quarter of 2022. Table 2 lists circuits identified as having the highest 5% of adjusted SAIFI statistics in 2021, as outlined in 20 CSR 4240.23.010 (6).

## 20 CSR 4240-23.010 (8) - Multi-Year Worst Performing Circuit Reporting

The referenced rule requires the plan and schedule to lower SAIFI metrics on circuits that are listed on the highest 5% SAIFI list for two out of three of the preceding years. Table 3 reflects the action plans identified to lower the SAIFI metric for these circuits. Evergy Engineering plans to work with an external provider to perform predictive diagnostic testing (ultrasound) on some recurring problems and issued corrective action jobs scheduled for completion during the 3<sup>rd</sup> and 4<sup>th</sup> Quarters of 2022. Additional patrols and root-cause analysis, where required, are planned to complete in 4<sup>th</sup> Quarter 2022.
