**ORDER DENYING APPLICATION TO INTERVENE OUT OF TIME**

On January 17, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively, Evergy) filed an Application for a variance from Chapter 13 regulations that appear in 20 CSR 4240 and relate generally to service and billing practices. On February 6, 2025, the Commission issued an Order setting the time for intervention at February 20, 2025. On March 4, 2025, Renew Missouri filed an application to intervene out of time. On March 11, 2025, Evergy filed an opposition to the application to intervene.

The Commission may grant an application to intervene after the intervention date upon a showing of good cause under Commission Rule 20 CSR 4240- 2.075(10). The Application has been available since January 17, 2025, and the deadline to intervene was February 20, 2025, and the mere mention of good cause does not excuse a simple failure to notice these deadlines. Under 20 CSR 4240-2.075(3)(a), Renew Missouri can surmount this burden but they must express an interest in the case that “is different from that of the general public and which may be adversely affected by a final order arising

from the case”. Renew Missouri has failed to explain why this case merits subverting the intervention rule and further failed to demonstrate any interest not shared by the general public.

The Commission will deny the untimely application for intervention.

**THE COMMISSION ORDERS THAT:**

1. Renew Missouri’s application for untimely intervention is denied.
2. This order shall be effective when issued.
