On June 22, 2009, I received the attached document from Gary Cover regarding Osage Water Company proposed rate increase. The Commission is currently considering the issues discussed in this document in Case Nos. WR-2009-0149 and ST-2009-0152 which are contested cases. The Commission is bound by its *ex parte* rule, and, I am therefore giving notice to the parties this communication has been received.

The report shall identify the person(s) who participated in the *ex parte* communication, the circumstances which resulted in the communication, the substance of the communication, and the relationship of the communication to a particular matter at issue before the Commission.

Please allow this to confirm our conversation following the public hearing conducted on June 12, 2009, in regard to the Osage Water Company proposed rate increase. District At 12 506

MEL Mills During both the question and answer session and the formal testimony, you raised concerns regarding the wastewater system at Chelsea Rose. You had a number of photographs of items that you believe were problems/concerns. During your formal testimony, you presented those photographs to the Missouri Public Service Commission and the Commissioner reviewed and noted the photographs and directed you to provide those to me so that your concerns could be addressed.

Following your testimony, you and I discussed the photographs. You refused to provide the photographs to me and you refused my offer to take the photographs and have them duplicated and return the originals to you. You then indicated that you would sell the photographs to me, but that you wanted \$50.00 for each of the 12 photographs, for a total of \$600.00. It was your position that "it's not my job to help you" and, thus, you continued to refuse to make arrangements for me to view and obtain copies of the photographs.

Obviously without the photographs, I cannot verify whether or not there even is a problem and certainly cannot take any corrective actions. Again, you have refused to provide me with photographs, despite being specifically directed to do so by the Chairman of the Missouri Public Service Commission.

Accordingly, I renew my offer to either pay a reasonable sum for copies of the photographs or, if you will provide me with the original photographs, I will make copies and return the originals to you. Unless and until I obtain the photographs and become advised as to the specifics of your concerns, there is obviously nothing I can do to take any corrective action.
