## ORDER DENYING REQUEST TO SHORTEN TIME FOR STAFF RECOMMENDATION

On March 14, 2025,<sup>1</sup> the Commission issued an order granting its Staff an extension to April 17 to file a recommendation with regard to Evergy Missouri West, Inc. d/b/a Evergy Missouri West's application.

On March 19, Evergy Missouri West filed a *Response to Staff's Motion for Extension and to the Commission's Sua Sponte Order Granting Staff's Motion for Extension of Time*, objecting to the March 14<sup>th</sup> extension order and requesting the Commission to order Staff to file its recommendation on or before April 7.

At the Commission's direction, on March 24, Staff filed a response to Evergy Missouri West's March 19<sup>th</sup> filing, requesting that the Commission uphold its March 14<sup>th</sup> order granting an extension to April 17 to file its recommendation.

The Commission will leave the April 17 deadline in place, but, upon Staff filing its recommendation, will consider shortening the time for responses.
