ORDER APPROVING COMPLIANCE TARIFF

On December 10, 2024, Spire Missouri Inc. (Spire) filed an Application to expand their existing certified areas thru the granting of a Certificate of Convenience and Necessity (CCN). On March 5, 2025, Spire was granted a CCN, subject to the condition that they file a revised tariff sheet. In an effort to comply with the Commission’s March 5, 2025 order, Spire filed Tracking No. JG-2025-0131 with an effective date of April 5, 2025.

The Commission ordered Staff to file a recommendation by March 21, 2025. Staff filed a Recommendation on March 14, 2025, stating that the Commission should approve the tariff sheet. No other responses were received.

The Commission reviewed the tariff filing and Staff’s Recommendation. The Commission will approve the tariff sheet.

THE COMMISSION ORDERS THAT:

1. The tariff sheet in Tracking No. JG-2025-0131, issued March 6, 2025, is approved to become effective on April 5, 2025.
