On December 10, 2024, Spire Missouri Inc. (Spire) filed an Application to expand their existing certified areas thru the granting of a Certificate of Convenience and Necessity (CCN). On March 5, 2025, Spire was granted a CCN, subject to the condition that they file a revised tariff sheet. In an effort to comply with the Commission's March 5, 2025 order, Spire filed Tracking No. JG-2025-0131 with an effective date of April 5, 2025.
