**ORDER DIRECTING FILING**

On December 13, 2024, the Staff of the Commission (Staff) filed its recommendation regarding the Actual Cost Adjustment (ACA) of Union Electric Company d/b/a Ameren Missouri. Staff proposes adjustments to the ending ACA balances. Staff listed several recommendations, and requested the Commission order Ameren Missouri to respond to those recommendations within 30 days.

The Commission directed Ameren Missouri to respond to Staff’s Recommendation. Ameren Missouri responded on January 15, 2025, in which it disagreed with a Staff adjustment.

The Commission convened a procedural conference for the parties to discuss their differences, and on February 25, 2025, Staff filed a Status Report. Staff requested the Commission to give the parties until March 26, 2025, to file a stipulation or status report. On March 26, 2025, Staff filed a Status Report. In that report, Staff stated that Ameren Missouri recently submitted additional information that Staff still needs to analyze. Staff asks the Commission to allow the parties an additional 30 days to file either a stipulation or another status report.

The Commission finds the request reasonable, and will grant it.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a stipulation, status report, or alternative pleading no later than April 25, 2025.
2. This order shall be effective when issued.
