On March 6, 2025, Evergy Metro, Inc. d/b/a Evergy Missouri Metro filed tariff sheet number 2.38, Tracking No. JE-2025-0132, to correct an incorrect tariff sheet. That tariff sheet bears an effective date of April 5, 2025.

Evergy Missouri Metro renumbered its Modified Pay As You Save (PAYS) tariff sheets assigning those sheets numbers 2.39-2.42, but did not withdraw tariff sheet numbers 2.37 and 2.38 with PAYS program information. Sheet number 2.37 was replaced February 16, 2025, but sheet 2.38 remained a PAYS tariff sheet.

The Commission's Staff recommended that the Commission make the adjustments described in Evergy Missouri Metro's cover letter accompanying its proposed tariff sheet number 2.38.

The Commission will approve the tariff sheet.
