ORDER GRANTING APPLICATION TO INTERVENE

White River Valley Cooperative, Inc. filed an application on February 19, 2025 pursuant to RSMo 386.800.3 and 20 CSR 4240-20.045, for an Order Approving Designated Service Boundaries. The Commission set a March 13, 2025 deadline for intervention and on March 13, 2025 Empire District Electric Company d/b/a Liberty ("Liberty") filed a timely application to intervene pursuant to Commission Rule 20 CSR 4240-2.075.

In their application to intervene Liberty is described as a Kansas corporation with its principal office and place of business at 602 S. Joplin Ave., Joplin, Missouri. Liberty states they have an interest different than the public interest and says they have taken no position regarding the factors before the Commission. Liberty states its intervention would serve the public interest. No objections to this intervention have been filed.

The Commission will grant the application for intervention.

1. The Intervention of Liberty shall be granted.
2. This order shall be effective when issued.
