ATXI has Violated the PSC orders set forth in :ORDER APPROVING UNANIMOUS STIPULATION AND AGREEMENT filed on 11/3/2021. Particularly pages 4,5,6,7, items 1,2,5,6,7. Regarding Item 8. A native burial site is on our property. it was disclosed to contract land staff. ATXI was aware of the burial site. The circuit judge illegally allowed it to be condemned. It will not be affected by the original transmission line, but is in the 345kv easement. Any Action by ATXI to damage the cemetery will be a felony and we will press charges. Additionally, ATXI Condemned 125' easements but only had approval for 100' based on Craig hiser testimony page 11, line 8-13

(response was they couldn't get it right now). However, it has still not been done. Discussed how they were missing a skidsteer bucket and how I was missing property as well. 2/22/2024 , pictures of escaped livestock in the ROW area through gate that was left open. Pictures of a boulder that rolled through the fence, and fence damage that was not repaired.

First email to Jim Jontry was sent on 2/4/2024 outlining damages and costs as of a result of ATXI actions. Site visit on 11/18/2024. Last contact was 2/25/2025 with ameren attorney Goff. No damages/losses have been paid.
