ORDER EXTENDING TIME FOR RECOMMENDATION

On January 28, 2025,¹ the Commission issued an order directing its Staff to file, by April 2, a recommendation regarding the application of Ameren Transmission Company of Illinois (ATXI) or a request for additional time to file its recommendation.

On March 31, Staff filed a *Status Report and Motion for Extension of Time to File Its Recommendation*, stating that Staff and ATXI have discussed holding local public hearings during April. Staff requests additional time to file its recommendation in order to incorporate into the recommendation findings from the local public hearings. Staff suggests an extension to June 2, which ATXI does not oppose.

In addition, Staff and ATXI request that the Commission direct the filing of a joint status report by all parties within two weeks of Staff filing its recommendation. The joint status report would address whether any party opposes the recommendation and would include, if needed, a proposed procedural schedule.

The Commission finds Staff’s motion reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. Staff's motion for an extension of time to file its recommendation is granted.

No later than June 2, 2025, Staff shall file its recommendation regarding ATXI's application.

2. This order shall be effective when issued.
