# ORDER GIVING NOTICE, SETTING A TIME TO REQUEST INTERVENTION, AND DIRECTING STAFF TO FILE A RECOMMENDATION

On April 1, 2025, USCOC of Greater Missouri, LLC d/b/a U.S. Cellular filed a request to relinquish its designation as an eligible telecommunications carrier (ETC). U.S. Cellular explains that the relinquishment is necessitated by the anticipated acquisition of U.S. Cellular's wireless business operations by T-Mobile US, Inc.

U.S. Cellular was designated an eligible telecommunications carrier in File No. TO-2005-0384. U.S. Cellular stated that it will notify the Commission of its requested effective date of its relinquishment upon approval by the Federal Communications Commission and after a closing date for the acquisition is known. U.S. Cellular believes that approval could occur by mid-2025.

The Commission will give notice of U.S. Cellular's filing, set a time for intervention requests, and will direct the Staff of the Commission (Staff) to file a recommendation.

#### THE COMMISSION ORDERS THAT:

1. The Data Center of the Commission shall send a copy of this order to each eligible telecommunications carrier in the State of Missouri.

- 2. Any proper person wishing to intervene in this matter shall file an application to do so no later than April 23, 2025.
- 3. Staff shall file its recommendation regarding U.S. Cellular's filing, or a request for an extension of time, no later than April 30, 2025.
- 4. Any other party wishing to respond to U.S. Cellular's filing shall do so no later than April 30, 2025.
  - 5. This order shall be effective when issued.
