ORDER GRANTING APPLICATION TO INTERVENE

Issue Date: April 2, 2025 Effective Date: April 2, 2025

On February 26, 2025,¹ The Empire District Electric Company d/b/a Liberty filed tariff sheets designed to increase its gross annual electric revenues. The Commission issued notice and set a deadline of March 25 for applications to intervene.

On March 21, Consumers Council of Missouri (CCM) timely filed an application to intervene. CCM stated that it is a non-governmental, nonpartisan, nonprofit corporation that is dedicated to educating and empowering consumers statewide and to advocating for their interests. CCM stated its interests are different than those of the general public and that its interest could be harmed as a result of a final order issued in this case.

CCM stated that it is opposed to increases in Liberty's revenue requirement if those increases are based on unjust or unreasonable actions. CCM stated it is generally opposed to unfair or discriminatory cost allocations. CCM stated it is opposed to an unreasonable residential rate design.

More than ten days have passed since the filing of CCM's application to intervene and no one has responded.² After considering the unopposed application to intervene, the Commission finds that CCM has interests which are different from the general public and which could be affected by a final order. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the application to intervene.

THE COMMISSION ORDERS THAT:

- 1. The application to intervene of Consumers Council of Missouri is granted.
- 2. This order shall be effective when issued.
