## ORDER DIRECTING STAFF RECOMMENDATION **ON COMPLIANCE TARIFF SHEETS**

Issue Date: April 2, 2025 Effective Date: April 2, 2025 On November 1, 2023, Spire Missouri Inc. d/b/a Spire filed tariff sheets reflecting changes to its Purchasing Gas Adjustment (PGA). The filing was intended to revise the PGA for the eastern (Spire East) and western (Spire West) Missouri operating divisions based upon Spire's calculations of its Actual Cost Adjustment (ACA) account balances for the 2022-2023 period.

On March 26, 2025, the Commission issued its Order Approving Stipulation and Agreement and Establishing Ending ACA Balance (Order) authorizing Spire to file tariff sheets that comply with the stipulation and agreement approved in the Order.

On April 2, 2025, Spire filed tariff sheets purporting to comply with the Order. The tariff sheets were assigned Tracking No. JG-2025-0143 and bear an effective date of May 2, 2025.

The Commission will direct its Staff to file a recommendation advising the Commission as to whether the filing complies with the Order.

### THE COMMISSION ORDERS THAT:

1. No later than April 16, 2025, Staff shall file a recommendation as to whether the tariff sheets filed by Spire on April 2, 2025, and assigned Tracking No. JG-2025-0143 comply with the Commission's Order Approving Stipulation and Agreement and Establishing Ending ACA Balance issued on March 26, 2025.

2. This order shall be effective when issued.
