STAFF NOTICE

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, and hereby respectfully submits this *Staff Notice*.

1. On March 19, 2025, Consolidated Communications Enterprise Services, Inc. d/b/a Consolidated Communications (“Consolidated Communications”) filed notice that they have changed their name to Consolidated Communications Enterprise Services, LLC. d/b/a Consolidated Communications, along with tariff adoption notices and revised title pages reflecting the new name.

2. Rule 20 CSR 4240-28.011(2) provides that any company with a certificate or registration that changes its name shall provide advance notice to the Commission of the name change and lays out the methods and requirements for such notice. Rule 20 CSR 4240-28.011(2)(B) states:

If the company maintains a tariff, then the letter must be accompanied by either a tariff filing that replaces the existing tariff in its entirety or a one-(1-) page adoption notice of the existing tariff.

3. Consolidated Communications maintains multiple tariffs with the Commission. While Consolidated Communications submitted proper adoption notices

and revised title sheets for the majority of its existing tariffs, Consolidated Communications failed to submit a proper adoption notice and revised title sheet for its Missouri P.S.C. Tariff No. 6.

4. Staff has reached out to Consolidated Communications alerting it of the deficiency in its filing and requesting that it file an additional adoption notice and title sheet for Consolidated Communications Missouri P.S.C. Tariff No. 6; however, as of the date of this filing, the company has not submitted the additional adoption notice and title sheet with the Commission. Staff requests that the Commission order Consolidated Communications to correct the deficiency with its filing.

WHEREFORE, Staff respectfully submits this *Staff Notice* and requests the Commission direct Consolidated Communications to submit an additional adoption notice and title sheet for its Missouri P.S.C. Tariff No. 6; and grant such other and further relief as it finds just in the circumstances.
