ORDER DIRECTING FILING OF ADDITIONAL ADOPTION NOTICE AND TITLE SHEET FOR TARIFF NO. 6

On March 24, 2025, Consolidated Communications Enterprise Services, Inc. requested that the Commission recognize its name change to Consolidated Communications Enterprise Services, LLC, and approve its adoption tariff sheets. The adoption tariff sheets were assigned Tracking Nos. JC-2025-0136, JC-2025-0137, JX-2025-0138, JX-2025-0139 and JC-2025-0140. The filed adoption tariff sheets relate to Missouri P.S.C. Tariff Nos. 1 through 5. The submitted tariffs sheets all have an effective date of April 18, 2025.

On April 3, 2025, the Staff of the Commission (Staff) filed a notice stating that an adoption notice and revised title sheet for Consolidated Communications' Missouri P.S.C. Tariff No. 6 was not submitted. Staff's notice stated that Rule 20 CSR 4240-28.011(2)(B) requires a tariff filing with the letter requesting a name change when the company maintains a tariff.

Staff requested that the Commission order Consolidated Communications to correct the deficiency with its filing. The Commission finds the request reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. No later than April 9, 2025, Consolidated Communications Enterprise Services, Inc. shall file either a tariff filing that replaces existing tariff Missouri P.S.C. Tariff No. 6 in its entirety or a one-page adoption notice of Missouri P.S.C. Tariff No. 6.
2. This order shall be effective when issued.
