
On April 3, 2025, SNGMO filed an application and tariff sheets to extend its Equipment Rebate Program (ERP) Pilot, with the tariff sheets bearing an effective date of May 3, 2025. SNGMO previously extended the proposed effective date of its ERP tariff sheets (Tracking No. JG-2025-0144) until June 7, 2025.

As of this date, SNGMO has filed a Stipulation and Agreement that, if approved, will resolve this matter. Consistent with the terms of that Stipulation, SNGMO hereby provides the attached substitute P.S.C. MO 3, Sheet No. 95, and withdraws P.S.C. MO 3, Sheets Nos. 92-94.

SNGMO further extends the proposed effective date of its ERP tariff sheet (Tracking No. JG-2025-0144) until June 14, 2025.


