ORDER CANCELING REGISTRATION

Issue Date: April 4, 2025

Effective Date: May 4, 2025

On March 11, 2025, Google North America, Inc. filed a letter seeking to cancel its registration to provide Interconnected Voice over Internet Protocol service (“IVoIP”) in the State of Missouri. The Commission granted Google North America, Inc. its IVoIP registration in the State of Missouri in File No. DA-2015-0222.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.¹

Based on Google North America, Inc.’s request, the Commission finds that the IVoIP registration granted to Google North America, Inc. shall be canceled.

IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Google North America, Inc. in File Number DA-2015-0222, is canceled.
2. This order shall become effective on May 4, 2025.
3. This case may be closed on May 5, 2025.
